TREES: Apply 225 grams per 25mm of trunk diameter. Distribute evenly under branches out to dripline. NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. Example: A 237ml. (1 cup) measuring cup holds approximately 227g. (1/4 kg.) of dry granular fertilizer.
