DIRECTIONS FOR USE:

Apply via Boom Spray, Fertigation unit or Fertispray.

Situation		Rate	Timing	Comments
Turf	Initial Inoculation	Apply 400g per hectare.	First Application	Drench in immediately following application with enough water to move product into thatch layer (eg. 4-10mm).
	Maintenance Application	Apply 200g per hectare.	Monthly	
Landscape / Ornamental Plants		Use 200g in 300-400L of water.	Apply 2 times per year	Soak roots at planting or apply as a drench.
Seedlings		20g/100m ²	Treat seeds prior to planting and at emergence.	Apply to seedling trays through irrigation making sure to drench the trays.

Avoid application when conditions are extremely hot. Best applied in temperatures in the range of 5 - 25 degrees Celsius. Preferably early in the morning or late in the afternoon.
